

Terms and Conditions

- Age Limits** – Family participants must be 6 years old or above and guardian must be 18 or above as of 2020. 3KM categories participants must be 13 years or above as of 2020. For 5KM and 10KM, participants must be 18 years old or above as of 2020. The Trellis Digital Company Limited (the “**Organizer**”) has the right to verify and request for verification of the age of participants before, during and after the race.
- Acceptance of Entries** – All entries are not transferable. Public entry is available on a first-come, first-served basis, and is not transferable. The Organizer will not accept any request for category change after the registration is completed. The Organizer reserves the right to cancel entry of any applicants without refund if they have provided false or incomplete information, fail to make the required payment, or fail to meet entry requirements. The Organizer also reserves the right to contact and interview applicants by phone or other means for any additional information required for their application.
- Entry Fee** – Entry fee is non-refundable once an entry is accepted. Participants can only withdraw and request for refund due to medical reason, Medical documents issued by medical practitioners (Registered to The Medical Council of Hong Kong or Overseas Governmental Medical Authorities) must be submitted to the Organizer.
- Duplicated Entries** – Each person is only allowed to register once. It is up to each applicant to ensure that there is only one registration for and by him / her. Any duplicated registration will be cancelled by the Organizer without giving prior notice. Duplicated entries cannot be used for redeeming the Runner’s Pack and entry fee paid will not be refunded.
- Terms & Conditions and Official Rules** – Upon submitting his/her entry, applicant agrees to accept all Terms & Conditions and agree to the Official Competition Rules as stipulated and also to those that maybe later introduced by the Organizer to regulate the smooth running of the event.
- Physical Conditions** – Participants should be aware of and understand the risks involved and the degree of fitness required for the race. It is the sole responsibility of the each Participant to ensure that he / she is physically fit to participate in and complete the race without any medical or other assistance. Any person who is pregnant or suffering from any chronic disease such as heart disease or high blood pressure should not participate in the event. The Organizer reserves the right to disallow / disqualify any person who is known or in the sole discretion of the Organizer, who appears or is suspected to be physically unfit to participate in the event. Participants are asked to seek medical advises of their physical condition before participating in the race. By submitting his / her application and subsequently taking part in the race, a Participant
 - warrants and confirms to the Organizer that he / she is physically fit to participate in and complete the race; and
 - agrees to indemnify the Organizer and Warner Bros. Consumer Products Inc., including each of their respective officers, directors, employees, consultants, agents, representatives, successors and assigns, and hold them indemnified and harmless for i) any injury or death suffered by the Participant himself / herself or any other persons; and ii) any damage to property as a result of him / her not being physically fit to participate in and complete the race.
- Disqualification** – The Organizer reserves the right to disqualify any person and / or nullify his or her result due to any violation, breach or non-observance of any Official Competition Rules set for this event. The Organizer shall not be obliged to refund any entry fee under such circumstances.

8. **Route Alteration**– The Organizer reserves the right to change or alter any parts of the running route before and during the race without prior notice to participants in the event of unexpected road conditions or emergency. The race may be temporarily suspended for the emergency vehicles access. Participants must follow the instructions of race officials or any law enforcement officers on site, in case of emergency.
9. **Instructions Given by Race Officials** – Instructions given by the Organizer and race officials must be followed with respect to all matters not provided herein. The Organizer reserves the right to reject applications of participants who refuse to follow instructions of the race officials for all future races organized by the Organizer.
10. **Results** – Official Time and Net Time will be provided to participants who have completed the designated races within the specified time limits wearing his / her bib. Split Times maybe provided and if so, they are for reference only. For 3KM only Official Time will be provided.
11. **Awards and Certificates** – Only participants of the 3KM, 5KM and 10KM Challenge races will be entitled to compete for awards. Official Times will be used to determine the prizes and positions. No awards will be offered to participants who take part in other categories for which he / she was not entered.
Certificate of Achievement and Progress Award certificate will be issued to all qualified runners with an Official Time in all races and categories. Participants who do not start the race according to the designed start time and assigned registered race category and participants who do not complete the race (including participants who boarded the Official Bus), shall not be entitled to any awards and certificates.
12. **Event Cancellation** – Should the event be cancelled due to circumstances beyond the control of the Organizer or force majeure, a refund of 50% of the entry fee will be made before 15 December 2020, and the Organizer shall have no further responsibility and/or liability thereafter.
13. **Premium** – Premium fee is non-refundable once a purchase is accepted.
14. **Personal Information Collection Statement** – Participants agree that the Organizers are permitted to collect, store and use his / her personal data (as defined and in accordance with the Personal Data (Privacy) Ordinance) as provided by himself / herself for the purpose of or in connection with the event (including but not limited to organization, promotion, and publicity of the event) and for the purpose of direct marketing in relation to the event or in relation to any services or products provided or sold by any sponsor of the event and that such collection, storage and use are lawful and fair in the circumstances.
Participants further agree that the Organizers may pass on such personal data to their agents, contracting parties, supporting organization and other related parties for the purposes mentioned above, in particular but without limitation to the event photographer, the media, the press and Warner Bros. Consumer Products Inc.
Participants also agree to grant permission to the Organizers and Warner Bros. Consumer Products Inc. to utilize his / her personal information, appearance, name, voice, bio-data likeness submitted by him / her or collected by the Organizer in connection with the event (“such information”) for the organization, promotion or publicity of the event. Participants agree that the Organizers shall own all rights (including without limitation, copyrights) in and arising from materials (e.g. photos, video, printed materials etc.) (“such materials”) that contains such information and the Organizers may exhibit, copy, edit, publish or use in other ways such information or such materials where necessary, and no further approval needs to be obtained from him / her and he / she also waives any right of inspection associated with such materials.
